Associate Member (membre adhérent)

Benefits

Full Individual Members are core to the association and help drive the EMMC forward. In particular, they enjoy the following benefits:

Organisational Member (membre organisationnel)

Description

This membership category is open and accessible to

- Any company with a presence in Europe interested in the modelling and digital representation of materials and integrated computational engineering
- Any national association having its registered office in Europe and furthering the interests of modelling and digital representation of materials at national level ("national associations")
- Any legal entity interested in the field, including universities and research institutes with a presence in Europe
- Other organisations may be accepted as Organisational Members subject to the approval of the Board of Directors

The participation of Organisational Members is critical to the success of the EMMC, helping to guide and support EMMC. Industrial End Users are key beneficiaries of advances in materials modelling and digital representation of materials. The EMMC is ready to receive their input and work with them on the development of best practices, standards, roadmaps, staff training, policy development, etc (see EMMC Activities). Software Companies are the enablers of the industrial success by taking forward academic research into innovative software products. RTDs are the origin of key advances in modelling very much required by industry.

Benefits

Membership of EMMC ASBL adds influence to an organisation's work on materials modelling in their sectors and markets by having a voice inside EMMC, providing advice on the needs of their sectors and the problems faced in the adoption of materials modelling and digitalisation.

Specific benefits of organisational membership of EMMC include
